Vision Statement

We believe that a good quality of life involves relationships of mutual respect, education and (or) meaningful work, real participation in community life, a stress-reducing rhythm of daily activities, seasonal celebrations, a rich artistic and cultural life, acceptance, individual recognition, and dignity for everyone. At the same time, Olympic Neighbors understands and values the rights of each individual to choose their own path and to be involved in making decisions that affect their own life.

Mission Statement

Creating home and community for people with developmental disabilities

Values

- 1. Inclusion We believe that people with developmental disabilities can live in the community, have a good quality of life and contribute to society in the same ways someone without a disability can.
- 2. Competence We promote self-reliance by providing opportunities and support those we serve to use the skills they already have and to develop the new skills they need to reach their individual goals.
- 3. Relationships We help those we serve maintain and develop relationships with a diverse community of people and we respect their right to choose their own friends and partners.
- 4. Integration We do not limit the activities and experiences of those we serve strictly to the disability community. We support those we serve to pursue their interests and overcome barriers to participate fully in the larger community.
- 5. Status We look for ways to help those we serve feel good about themselves and about how they are perceived by others.
- 6. Power and Choice We pay attention to and take seriously the expression of individual goals and desires. We promote opportunities for those we serve to make informed decisions and to take responsibility for the outcome of their choices
- 7. Health and Safety We promote personal health and well-being by offering assistance with hygiene, nutrition, exercise and access to medical care. We identify the risk for abuse, neglect, or exploitation for those we serve and we provide education, advocacy and protection. We balance the need for safety with other values that are important to those we serve
- 8. Self-Determination The purpose of our work is to help those we serve increase the power they have over their own lives, to help them participate fully in society, and to help them achieve the lifestyle and goals they set for themselves.

Goals and Actions

The following are Olympic Neighbors strategic plan goals and actions. Included are both accomplishments for 2015 – 2019, as well as specific goals and actions for June 2019 – June 2020 and more generalized goals and actions for the time period of June 2020 through December 2024.

Housing

Accomplishments 2015 – 2017

- Obtained house for AFH, constructed facilities/rooms to accommodate 6 total residents, and applied for State license and have been responding to licensing requests from licenser
- 2 residents living at Adult Family Home (AFH)
- 4 additional residents identified, including both male and female, that can move into home when State licensing is complete

Accomplishments 2018 – 2019

- Licensed by DSHS on Feb. 2018
- Hamilton House (HH) AFH full by end of Dec. 2018 with six residents living a life-sharing existence, tied to greater community.
- We are developing expertise in operating and sustaining operation of HH AFH fine-tuning costs, expenses, necessary annual income, staffing and employment, resident needs
- Developed an informal resident application process and wait list
- Began exploration of additional supported living options and programs to support DD community housing needs
- Researched other AFH structures Connecting Links, Community Homes and 24/7 AFH
- Obtained input and advice from professionals on supported living/needs Lesley Shinebaum, Susan Almquist (Region 2 DDA),
- Developed housing partnership with other OlyCAP

Goals for 2019

- Significantly expand residential support services to the DD Community by exploring residential service options:

 - Future AFH options
- Apply to become a Supported Living provider with DSHS
- Formalize application/waitlist process and exit process develop a policy or written procedure

- Goal by 2024 is to have additional supported housing to provide housing for an addition of 12 developmentally disabled, for a total of 18.
- Continue developing expertise in operating and sustaining operation of HH AFH fine-tune costs, expenses, income, staffing and employment, resident needs
- Build capital and operating reserves (3 -4 month reserve)
- Maintain waiting list for housing candidates
- Explore options for Kennedy Road

Funding

Accomplishments 2015 - 2017

- In 2017
 - Obtained \$105,002.50 in donations and grants
 - Received 117 one-time donations from 112 individual donors
 - Hosted 13 local fundraising events (2nd annual Pourhouse, 3 Bingos, 3 Farmers Markets, Garage sale, Craft Fair, 2 online giving campaigns, and 3 dinners
 - Gained 142 followers on Facebook
 - Received funding from 5 local organizations and churches
 - Received 4 local grants (UGN, Skookum, Friendship, and Home Depot)
 - o Received significant discounts on building supplies and services
 - Met with a non-profit advisor on methods for fund-raising
 - Researched approaches for hiring grant writer
 - Approved 2018 budget that included estimated expenses, State funding, and shortfall needing other sources of revenue
- Began 2015 with less than \$1,000 in bank account and ended 2017 with \$71,266.31 in account and an AFH facility addition complete

Accomplishments 2018 - 2019

- In 2018
 - Obtained State financial support for AFH residents (40% of revenue came from DSHS/Client Participation)
 - Hired Program Coordinator to fundraise
 - Applied for 8 grants (2 less than goal of 10)
 - Increased donor retention from 28% to 48% (did not meet goal of 75%)
 - Received less than 2% or revenue from grants (did not meet goal of 30%) from Sunrise Rotary and UGN
 - Met goal for fundraising \$80,000-\$100,000/year (raised \$144,000 \$100,000 came from board giving)
 - Acquired at least 107 new donors
 - Increased Facebook followers to 309 (met the goal of increase by 150 followers)
 - o Increased revenue from Summer Bash annual fundraiser
 - Created new fundraising revenue through Gallery Walk Cup event
 - Produced a monthly enewsletter for donors and quarterly paper newsletter (focused on impact; not an ask)
 - Develop at least 2 new Community Partnerships with Coldwell Bankers and LaughinGnome Pottery (did not meet the goal of 5 local Organizations)
 - Built a donor retention programs (i.e. quarterly outreach with impact reports)
 - Developed fundraising calendar with a goal of income expected for each event
 - Sold Sofia artwork/donation

- Invested in donor software Bloomerang
- Managed overhead cost at 35% (did not meet the goal of less than 23%. This does not include direct staff costs)

In 2019

- Increased state financial support for AFH residents by serving 6 residents. We expect a minimum 68% of annual revenue to come from DSHS/Client Participation
- Obtained ETR for 1 resident
- Applied for 9 grants so far, received 4 (counting 2 that came over from 2018) from JCF, 1st Federal, UGN and Kiwanis. Have received 6% of expected annual revenue from grants.
- Donor retention has increased to 60%
- Advocated for AFH rate increases (SB5672)
- Added fundraising events ice cream, Wooden Boat Fest Craft Sale, Give Big
